The person is liable, for the period during which the ineligible student is enrolled, for the greater of: (1) the maximum tuition fee the district may charge under Section 25.038 of this code; or (2) the amount the district has budgeted for each student as maintenance and operating expenses. (A person found guilty of falsifying information on an enrollment form may be liable for tuition for a sum in excess of \$5,000.)
